I-94 **East** (Waukesha, Madison, Appleton, Oshkosh, Fond du Lac, Eau Claire, LaCrosse) I-94 **West** (Racine, Kenosha, Chicago) I-94 East to the 35th Street exit. Turn right (south), and continue on 35th Street (approximately 3 miles) to Dakota Street (two blocks south of Forest Home Avenue). Turn left (east) onto Dakota Street. The entrance to the Conference Center and parking structure is on the left (north) side of Dakota — 2920 West Dakota Street.

I-94 West to the 894 bypass (to Madison). Continue on the 894 bypass west to the first exit — 27th Street-North. Turn right (north) onto 27th Street. Continue north on 27th Street to Dakota (two blocks north of Oklahoma Avenue). Turn left (west) on Dakota. Go 1/2 block past 29th Street. The entrance to the Conference Center and parking structure is on the right (north) side of Dakota — 2920 West Dakota Street.

I-43 **North** (Janesville, Beloit, East Troy, Rockford) I-43 North to the 894 bypass. Continue on the 894 bypass to the 27th Street exit. Turn left (north) onto 27th Street. Continue north on 27th Street to Dakota (two blocks north of Oklahoma Avenue). Turn left (west) on Dakota. Go 1/2 block past 29th Street. Go right (west) on Holt Avenue (which becomes Morgan Avenue) to 27th Street (approximately 2.5 miles). Turn right (north) on 27th Street to Dakota Street (two blocks north of Oklahoma Avenue). Turn left (west) on Dakota. Go 1/2 block past 29th Street. The entrance to the Conference Center and parking structure is on the right (north) side of Dakota — 2920 West Dakota Street.

From **Downtown**Milwaukee
